TERMS AND CONDITIONS

Organiser : Dutch Lady Milk Industries Berhad (196301000165/5063-V) **Contest Name:** Peraduan CERIA Si Manja! Bersama Dutch Lady® **Contest Period :** The Contest starts at 00:00:00 on 6th August 2020 and closes at 23:59:59 on 16th September 2020.

Eligibility : The Contest is open to all Malaysian citizens and permanent residents in Malaysia aged 18 years and above with valid identification number (MyKad or MyPR) as on 6th August 2020.

The following groups of persons shall not be eligible to participate in the Contest:

- Employees of the Organiser and its group of companies and their immediate family members (spouse, children, parents, siblings, and their spouses);
- Employees of the Organiser's agencies associated with the Contest and their immediate families (spouse, children, parents, siblings, and their spouses).
